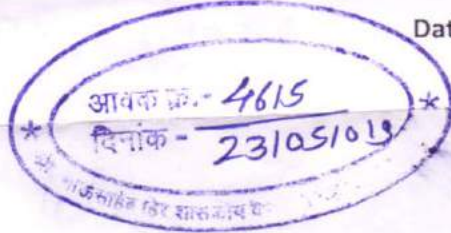

Sub.:- Recognition/approval of Shri Bhausahab Hire Government Medical College, Dhule for the award of MBBS degree granted by Maharashtra University of Health Sciences, Nashik against the increased intake i.e. from 50 to 100 seats u/s 11(2) of the IMC Act, 1956 - reg.

Sir,

I am directed to inform you that an assessment to verify the compliance submitted by the college authorities on the deficiencies pointed out in the earlier assessment report with regard to recognition/approval of Shri Bhausahab Hire Government Medical College, Dhule for the award of MBBS degree granted by Maharashtra University of Health Sciences, Nashik against the increased intake i.e. from 50 to 100 seats u/s 11(2) of the IMC Act, 1956 was carried out by the Council assessors on 08.04.2019. The compliance verification assessment report (08.04.2019) alongwith the summary/observations of the member of the Undergraduate Expert Group appointed by the Board of Governors in supersession of Medical Council of India was considered by the Board of Governors in supersession of Medical Council of India and decided to recommend to the Central Government for recognition/approval of Shri Bhausahab Hire Government Medical College, Dhule for the award of MBBS degree granted by Maharashtra University of Health Sciences, Nashik against the increased intake i.e. from 50 to 100 seats u/s 11(2) of the IMC Act, 1956.

The Board of Governors in supersession of Medical Council of India further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16th April 2010 and act accordingly at appropriate time, which reads as under:-

8 (3) ...

(2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.

(3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.

(4) Failure to seek timely renewal of recognition as required in sub-clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute."

In view of above, you are requested to issue necessary notification at the earliest recognizing Shri Bhausahab Hire Government Medical College, Dhule for the award of MBBS degree when granted on or after December, 2017 by Maharashtra University of Health Sciences, Nashik against the increased intake i.e. from 50 to 100 seats.
